TERMS & CONDITIONS - U.S.A.

Sept 1 to Oct 31, 2016 Consumers who buy four Dick Cepek DC Terrain, DC Matrix, DC Blackout, DC-2 Black, or DC Torque wheels will receive a \$75 Prepaid Card by mail and consumers who buy four Dick Cepek Trail Country Tires will receive a \$50 Prepaid Card by mail and consumers who buy four Fun Country or Extreme Country tires will receive a \$100 Prepaid Card by mail. Here's how:

1. This offer is open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico making purchases in participating retail stores in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased four new qualifying Dick Cepek tires and/or wheels in a single transaction for personal household use. Properly submitted and verified claims will be provided with the reward (as described below) in U.S. dollars in the form of a Dick Cepek Tires Visa® Prepaid Card, to be mailed to the address provided on this official mail-in form. Cards will not have cash access and can be used everywhere Visa debit cards are accepted. This card is not a line of credit, will expire 6 months from the month of issuance, and is subject to the terms and conditions placed on it by Visa and the issuer of the card.
