## TERMS & CONDITIONS - USA

**Sept 1 to Oct 31, 2015 Consumers who buy four Mickey Thompson Classic III, Classic III Black, Classic Baja Lock, Sidebiter II, Deegan 38 Pro 2, Deegan 38 Pro 4, MM-164B, MM-164M, MM-245, MM-366, or MM-489 wheels will receive a \$75 Prepaid Card by mail and consumers who buy four Mickey Thompson Baja STZ, Baja ATZ P3, Baja MTZ, Baja MTZ P3, Baja Claw TTC, or Deegan 38 tires will receive a \$100 Prepaid Card by mail. Here's how:**

1. This offer is open to legal residents of the 50 United States, the District of Columbia, and Puerto Rico making purchases in participating retail stores in those locations. The mail-in offer is not transferable and is valid only for the individual who purchased four new qualifying Mickey Thompson wheels in a single transaction for personal household use.
